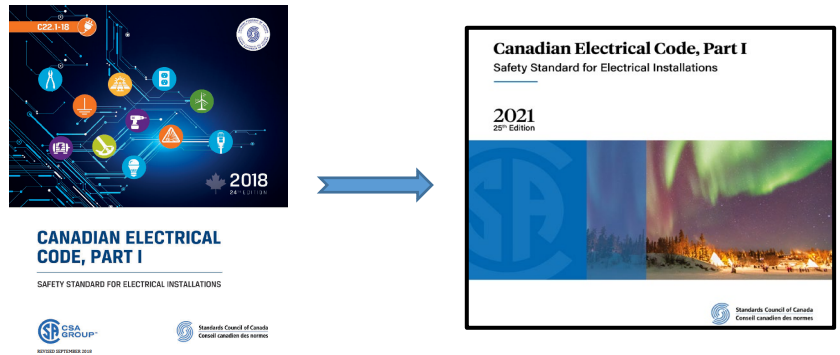

FIELD SAFETY REPRESENTATIVE (FSR) ELECTRICAL CODE CONTINUING EDUCATION



Starting August 2, 2022

BCIT' 2021 FSR Renewal class is approved for all Technical Safety BC FSR classes

- BCIT, its course instructors and FSR electrical code continuing education renewal classes are approved and recognized by Technical Safety BC
- The instructor led, interactive course is approved to instruct to all FSR classes. This course is required for all FSR's wanting to renew their FSR certificate of qualification or for those wanting to know what's new with this version of the Electrical Code or

Before you can renew your certificate of qualification, Electrical Safety Regulation (Section 10.1) requires all Class A, B or C Field Safety Representatives (FSRs) to complete 8 hours of continuing education, and 4 hours of continuing education for restricted class FSR's.

Consequences of not renewing

If you do not renew your certificate, but continue to perform regulated work, these are some of the consequences of working with an expired certificate:

- Any contractor licence you're named on becomes invalid, along with any associated installation or operating permits
- You cannot be named on any new or renewed operating permits, installation permits, temporary construction permits, and contractor licences
- You cannot assess compliance with current codes and regulations
- You cannot submit declarations of compliance
